

令和5年度地下水の水質測定結果について

1 内 容

水質汚濁防止法第15条の規定により、地下水の水質の汚濁の状況を把握するため、岡山市及び倉敷市と協力して、測定を実施した。

(1) 対象項目

地下水の水質汚濁に係る環境基準が定められている環境基準項目(カドミウム等28項目)及び要監視項目(クロロホルム等25項目)

(2) 測定方法

表1のとおり、県内31地点において概況調査を行うとともに、過去にトリクロロエチレン等による汚染が確認された4地点で継続監視調査を行った。測定項目及び頻度については、表2のとおりである。

2 結 果

(1) 概況調査

31地点のうち1地点で環境基準を超過した。超過地点及び超過項目については表3のとおりである。

(2) 継続監視調査

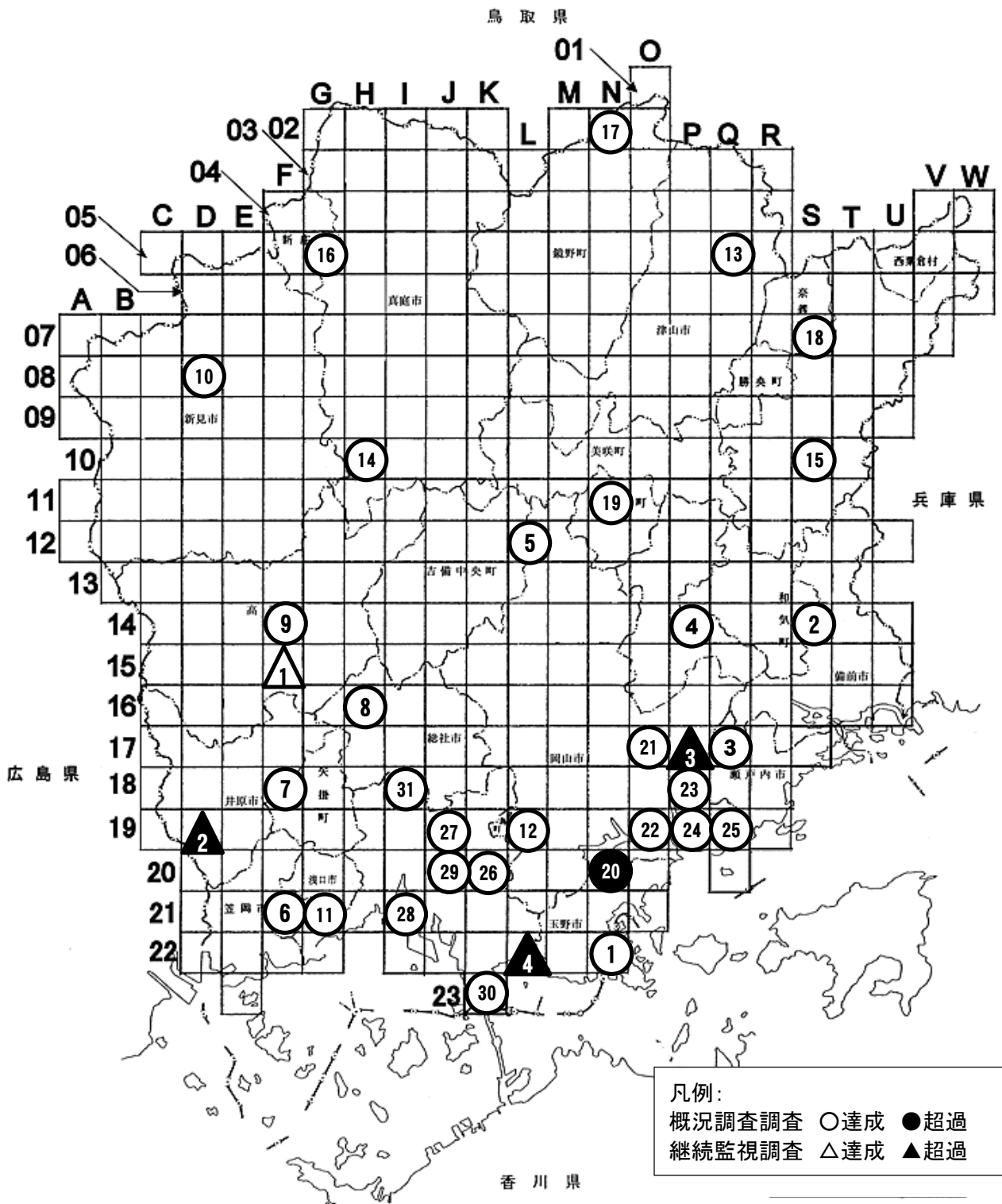
4地点のうち3地点で、依然として調査対象物質が環境基準を超過していた。

3 今後の対応

概況調査で環境基準を超過した地点は、施肥由来と判断されることから調査を終了する。

継続監視調査を行った4地点は、引き続き調査を継続する。
